TERMS AND CONDITIONS:

- Breeding Fee: The Breeding Fee as stated, to be paid by the Mare Owner to the Stallion Owner is \$1,750.00 in CAD funds or \$1,450.00 in US funds(1).
- 2. **Booking Fee**: A booking fee of \$650.00 in CAD funds *or \$500.00 in US funds(i)* **is included** within the **Breeding Fee**.
- 3. **Collection Fee**: A collection fee of \$250.00 in CAD funds *or* \$225.00 in US funds() is included in the **Breeding Fee** and applies to the first collection **exclusively**. Subsequent shipments will be subject to the **Collection Fee**, and all collections are subject to shipping fees.
- 4. **Credit Card Authorization:** We require credit card authorization as part of this contract, and will be used exclusively for shipping fees and any subsequent collection fees(2). Breeding fees will be collected exclusively from our online store.

1 All US Funds referred to in this contract are subject to changes in exchange rates.

2 The Credit Card Authorization Form will be sent to you in a separate document, to be filled out and signed online. The Credit Card Authorization Form is a requirement of this contract, and we will not collect until we receive this form completed in full, and without any errors.

3 If a discount is awarded as part of a promotion, we will amend the Breeding Fee, as referred to in this contract, to reflect the promotional discount.

4 The Semen Request Form is available on our website, and must be filled out and signed online. The Semen Request Form is a requirement of the breeding farm, and we will not collect until we receive this form completed in full, and without any errors.

BREEDING AGREEMENT

- 5. The **Breeding Fee** is due upon the signing of this agreement. Any promotional discounts will be noted in a seperate document(3).
- 6. Tax: 13% HST applies to all Canadian Purchasers.
- 7. **Semen Collection Requests:** Written requests for semen must be received by *10:00*AM EST on collection days, without exception, and must be filled out online via the *Semen Request Form*(4), which is available on our website. Collection days will be Monday through Friday, and delivery from Monday through Saturday, depending on delivery location.
- 8. The Mare Owner agrees to breed exclusively to the Mare, as stated within this agreement.
- 9. **Live Foal Guarantee**: Should the **Mare** fail to conceive, abort, die, or not produce a *live foal*(5) then the **Stallion Owner** guarantees the **Mare Owner** shall have the right to re-breed or substitute a mare, upon discretion of the **Stallion Owner**, within the current **or** the following *breeding season*(6) exclusively. The **Collection Fee** and any related shipping fees are applicable to any subsequent collections.
- 10. Embryo Transfer: For embryo transfer breeding, we will honour the **Live Foal Guarantee** on one foal. For subsequent pregnancies, there will be an additional fee of \$1,050.00 in CAD funds *or* \$750.00 in *US funds(i)*. Subsequent pregnancies will not be subject to the **Live Foal Guarantee**.
- 11. Party In De Hus is **negative** for **EVA** and **WFFS**.
- 12. This agreement **must** be used within the next two *breeding seasons*(6).
- 13. The **Mare Owner** and the **Stallion Owner** agree that the terms and conditions stated herein are set for the entire duration of the **Breeding Agreement**.
- 14. The **Breeding Agreement** shall be interpreted in accordance with the laws of the Province of Ontario, and its validity and administration shall be governed by said laws.
- 15. The termination of this contract, if terminated by **Mare Owner**, is non-refundable in its entirety, **no exceptions**.
- 16. All sales are final.
